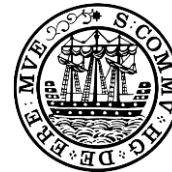

HARBOUR TAXI SEASON TICKET HOLDERS
ANNUAL MOORING HOLDER AND VISITOR PERMITS
TERMS AND CONDITIONS

- 1 Season Tickets, issued on payment of the appropriate fee, must be shown on every trip on the Harbour Taxi.
- 2 If a Season Ticket is not shown, you will be required to pay the applicable single fare.
- 3 The issue of a Season Ticket does NOT guarantee the availability of the water taxi immediately.
- 4 Season Tickets are only valid within advertised operating hours.
- 5 The Season Ticket is valid for trips to and from the vessel named on the ticket.
- 6 The primary boat owner/user will be named on the first season ticket and will only be valid for that person. Any subsequent ticket will be named Crew 1, Crew 2 etc. Each ticket will be £60 and will only be valid for one person per trip.
- 7 Yarmouth Harbour General Directions are applicable under the terms of the Season Ticket, a copy of which is displayed at the Harbour Office.
- 8 As a condition on the licence to carry passengers, the water taxi will not operate in very rough weather.
- 9 Yarmouth Harbour Commissioners may withdraw/relinquish a Season Ticket at any time.
- 10 For 2018 Season Tickets will be valid from date of issue to 31st December 2018.
- 11 It is the responsibility of the Season Ticket Holder to notify any change of address/boat in writing.
- 12 The loss of a Season Ticket should be reported in writing immediately. A replacement Season Ticket will be issued for which an administrative charge of £5 is payable.
